Meet Our New Youth Pastor



Beginning June 1, Larry Graack, along with his wife Bridgette, will become our new PAC Youth Pastor. Pastor Larry brings a set of background experiences that make him uniquely prepared for this important ministry role. He was born into an abusive home, and then raised by his grandparents in Arizona, the back hills of Kentucky, and Southern California. When their home burned to the ground, the family learned to rely on God and the kindness of friends. In his youth he spent time at Pine Springs Ranch, where he made a personal commitment to Christ and found a calling to youth ministry.

While pursuing a theology degree at Pacific Union College, Pastor Larry engaged in a variety of ministries and served as the Religious Vice President for the Student Association. Graduating during the recession, when pastoral openings were extremely limited, he took a job as a literature evangelist. Then he served as a missionary in Korea for a year and a half, where he taught English and Bible classes, and was a ministry coordinator. When Pastor Larry returned to the States, he became a taskforce pastor in a bilingual church. It was during this time that Larry and Bridgette met. This ministry experience was followed by two years as a local hire youth pastor stint in the Placerville church, and then served as an enrollment counselor at Pacific Union College. During his time at PUC, he founded Connect Ministries to help students learn to preach, do music ministry, lead, and serve in various campus venues.

Living In Jesus, Sharing God's Love

While transitioning from PUC to youth ministry in the Palo Cedro church, Pastor Larry was diagnosed with cancer. Through this difficult time, he learned to trust God with whatever the outcome may be. In time, Larry was healed, and a year later he and Bridgette married.

Pastor Larry and Bridgette have been at Andrews University for the past two years where Larry has pursued his Master of Divinity degree, with a dual focus in chaplaincy and marriage/family life ministries. He has also organized an honors society to inspire academic excellence in the seminary community.

Pastor Larry enjoys playing chess. Ju-Jitsu, fishing, and kayaking are also an important part of his life. More than anything, Pastor Larry enjoys a growing relationship with Jesus, and is eager to share the love of Jesus with our Paradise youth, church family, and community.



Adventist Health Provides COVID-19 Vaccinations to the Community




Adventist Health (AH) held its first two COVID-19 vaccine clinics for the public on March 12 and March 19. Vaccines were provided by appointments only.

"We are pleased to be able to offer COVID-19 vaccine appointments to the public," said Bev Roberson, RN, BSN, Quality Nurse Manager. AH follows the CDC protocols for administering the vaccine according to the prioritization tiers and provided vaccinations to individuals aged 65 and older, or adults aged 18-64 who had 'severe co-morbidities' that affected their health status.

Individuals who are interested in obtaining the vaccine can call the Customer Support Center at 530-872-2000 to make an appointment for an upcoming vaccine clinic. As appointments are filled, individuals who qualify may be put on a waiting list for upcoming clinics.

"Adventist Health is committed to supporting our patients and our community by providing COVID-19 vaccines," noted Tim Williams, Administrative Director, Physician & Outpatient Services. "As more vaccine becomes available to us, we will continue to provide these vaccine opportunities for our community members."



Adventist Health Partners with Hope City



Adventist Health (AH) is supporting the efforts of Hope City (a division of Hope Crisis Response Network (HCRN), to house volunteers who are here to help rebuild the ridge. HCRN is a faith-based humanitarian non-profit organization that serves in all phases of disasters providing volunteer services to help cleanup and home rebuild/repairs, community recovery development, and much more. Hope City is here to serve the ridge communities following the Camp Fire, coordinating volunteers to come in as groups or individuals to support lot prep, site work and tree removal that is necessary to help homeowners to rebuild.

Hope City, a member of the Camp Fire Collaborative, is currently housing some of these volunteers in the community by leasing space owned by AH. "This is an amazing example of aligning with our AH mission," said Tim Williams, Administrative Director, Physician & Outpatient Services. "As we continue to find ways to support the rebuilding of the community we serve, we are pleased that we can partner with organizations such as Hope City."

Hope City collaborates with AmeriCorp and works with sponsors and partners to provide housing and support for the volunteer teams that are anxious to help communities that have been devasted by disasters. In Butte County, Hope City expects to rebuild 185 homes for families that are not financially able to rebuild without this type of help.

March 3, 2021 NCC Executive Meeting



On Wednesday, March 3, the Conference Executive Committee (CEC) held its quarterly meeting via Zoom. Carmichael church Senior Pastor Keith Jacobson presented a devotional message to begin the session, which was followed by a time of prayer. Some highlights of the CEC meeting include:

Jacobson gave a report about early plans for a center of influence in the Sacramento area – the Life Hope Center. Beginning with the food distribution efforts the Carmichael church is currently spearheading, the center will eventually provide multiple services to help community members.

President's Report: CEC members viewed President Marc Woodson's State of the Conference video message, which is being shown during local church worship services. : (10) State of the Conference - NCC President Marc Woodson - YouTube Watch it here.

Executive Secretary Jose Marin gave an extensive report on NCC membership.

At the end of 2020, the NCC had 40,699 members, 147 churches, and 17 companies.

During the fourth quarter of 2020, 137 people in NCC congregations joined the Adventist Church through baptism and 24 joined through profession of faith, including:

- Paradise church and Fairfield Suisun Spanish church - 7 baptisms each
- Red Bluff church 10 baptisms
- Granite Bay Hilltop church 16 baptisms, 4 professions of faith.

During 2020, 384 people in NCC congregations joined the Adventist Church through baptism and 91 joined through profession of faith, including:

- Oakland Spanish church 12 baptisms
- Oroville church 16 baptisms, 1 profession of faith
- Granite Bay Hilltop church 30 baptisms, 12 professions of faith

Special Mentions:

- Dobbins church (32 members) 5 baptisms
- SDA Abundant Life church, Petaluma (73 members)
 15 baptisms, 3 professions of faith

2020 Baptisms/Professions of Faith Analysis by Age:

- Children Up to Age 13 17%
- Teens 14-17 10%
- Young Adults 18-29 8%
- Adults 30 and Older 27%
- Unknown 38%

Executive Secretary's Report: Online worship services have allowed local churches to expand their outreach. A good example is the Oakland Elmhurst church. Its online worship service received an average of 6,847 views each Sabbath in the fourth quarter of 2020.

Earlier this year, the NCC held its first-ever online training sessions for local church clerks. Also, training in Spanish was offered for the first time. In all, 60 church clerks participated, including one from Hawaii.

The ACTS Church Planting Support System will be coming to Leoni Meadows, May 3-5.

Financial Matters: The NCC tithe total for 2020 was nearly \$483,000 more than for 2019 – a cause for rejoicing and thankfulness!

NCC Treasurer John Rasmussen and Associate Treasurer Sonnett Peterson presented reports on various budgets, funds, and investments.



The CEC voted to approve the 2020 Financial Report, subject to audit, and voted to approve the (balanced) 2021 Operating Budget, subject to audit.

The audit review subcommittee, chaired by CEC member Robert Chiles Sr., presented its report, which the CEC voted to accept.

Meeting: The CEC approved the following people to serve on the NCC nominating committee, which must nominate 74 delegates for the upcoming Pacific Union Conference constituency session to be held Aug. 15-16, in Tucson, Arizona.

Other Business: The committee accepted the resignation of Shirley Abell, who has left the CEC because she has moved out of the conference territory. The NCC administrators greatly appreciate her service!



The CEC approved three new members of the Rio Lindo Adventist Academy Board: Sheilvina Knight, Grand Advent church member; Shaun Lazarus, Redwood Adventist Academy principal; and Rick Nelson, Ukiah Junior Academy principal.

The committee voted to approve the dissolution of the Bieber company due to very low membership. Rich Magnuson, director of Planned Giving & Trust Services/Property Management, reported on the ongoing sale of the former NCC office building and property in Pleasant Hill.

Woodson presented the results of a recent CEC member survey, which asked about ways that the quarterly meetings can be more effective.
